## **RESORT RULES**

1. **OFFICE HOURS-** Mondays to Fridays 07h45-12h45 / 13h30 -16h30  
Saturday / Sunday 07h45-10h00
2. **PAYMENT-** ALL OUTSTANDING BALANCES MUST BE PAID BEFORE ARRIVAL.
3. **DEPOSIT-** 50% OF TOTAL BALANCES NEED TO BE PAID AFTER 7 DAYS OF FIRST BOOKING.
4. **ARRIVAL AND DEPARTURE TIMES-** Arrival time between 14h00 to 20h00  
Departure time 10h00 strictly
5. **SPEED LIMIT-** 30 km/h
6. **QUIET TIME AFTER 23H00.**
7. **PROHIBITION-** NO FIREARMS, DOGS, MOTORBIKES OR QUAD BIKES
8. **NO DAY CAMPING / DAY VISITORS ARE ALLOWED**
9. **NO MUSIC CENTRES/ KARAOKE SYSTEMS ARE ALLOWED.**
10. **NO BEDDING IS PROVIDED.**
11. **ONLY SIX PEOPLE PER CHALET.**
12. **CAMPER AND CHALET RENTEE VEHICLES ARE PARKED AT OWN RISK.**
13. **NO CAMPER WILL INTERFERE WITH THE DUTIES OF RESORT SECURITY.**

14. **THE FOLLOWING FOR SECURITY REASONS: GATES OPENS AT 06H00. NO VEHICLES WILL BE ALLOWED TO ENTER / EXIT THE PREMISES BEFORE 06H00 WITHOUT PRIOR ARRANGEMENTS. GATES CLOSES AT 22H00. NO VEHICLES WILL BE ALLOWED TO ENTER / EXIT THE PREMISES AFTER 22H00 WITHOUT PRIOR ARRANGEMENTS.**
15. **ALCOHOL MAY NOT BE GIVEN TO EMPLOYEES OR SECURITY.**
16. **VANDILISM IS PROHOBITED ON THE RESORT. WHEN A PERSON MAKES HIM/HER GUILTY OF SUCH ACTION THEY WILL BE CRIMINALY CHARGED.**
17. **FISHING (07H00 tot 19H00) – NO FAMILY IS ALLOWED.**
18. **KEEP THE RESORT AT ALL TIMES TIDY.**
19. **CHALETS / CAMPINGSITES MUST BE CLEANSED BEFORE DEPARTURE.**
20. **PLEASE SUBMIT ALL ENQUIRIES AND COMPLAINTS TO THE OFFICE.**
21. **RESPECT YOUR FELLOW CAMPER AT ALL TIMES.**
22. **THOSE WHO DO NOT ADHERE TO THE ABOVE RULES WILL BE ASKED TO VACATE THE PREMISES.**

**PLEASE NOTE:**

**1. CARAVAN / TENT SITES:**

Only **one** caravan/ tent /vehicle per site will be allowed.

A maximum of 6 people per site are allowed.

All visitors will be considered as day visitors.

No pets are allowed.

Open fires will only be permitted at designated areas.

Fish are only allowed to be cleaned at designated areas.

Only firm electrical cords may be used from the power point to the caravan/ tent.

Electrical equipment will strictly be limited to standard electrical caravan equipment.

Basin plugs must be supplied by you.

Damage to property will not be tolerated may lead to prosecution.

No sea life may be removed from the rocks.

No tent ropes to be tied on to poles in the resort.

**UNDER NO CIRCUMSTANCES WILL “ARMY TYPE TENTS” BE ALLOWED. YOU WILL BE ASKED TO LEAVE THE PREMISSES IMMEDIATELY.**

**ABSOLUTE SILENCE MUST BE ADHERED TO AS FROM 23H00 PLEASE CONSIDER YOUR FELLOW CAMPERS.**

## 2. CHALETS

Maximum of 6 people per chalet.

Chalets can be occupied after 14h00 on the day of arrival and must be vacated by 10h00 on the day of departure.

No furniture (chairs, tables, etc.) may be removed from the chalets for use outside.

Damage to property will not be tolerated/may lead to prosecution.

No pets are allowed.

Electrical equipment will strictly be limited to standard electrical equipment.

Open fires will only be permitted at designated areas.

**ABSOLUTE SILENCE MUST BE ADHERED TO AS FROM 23H00. PLEASE CONSIDER YOUR FELLOW CAMPERS.**

## 3. LAPA

This facility is rentable to organized groups for 60 people and **not** for the use by the Campers and Day visitors.

Fires will only be permitted at designated areas.

Electrical equipment will strictly be limited to standard electrical equipment.

No one is allowed to overnight in the Lapa.

Damage to property will not be tolerated/may lead to prosecution.

**Hiring of the facility is affective from 10h00-16H00 / 18H00-24h00 strictly.**

**Absolute silence must be adhered to as from 24h00. Please consider your fellow campers.**

### YOU ARE KINDLY REQUESTED:

To use water and electricity sparingly.

That all functions at the **main hall/ lapa** must have a **guest list**.

To keep ablutions blocks clean and tidy at all times.

To report vandalism immediately to management.

Not to damage our trees.

To use marked footpaths to and from the sea.

That children under the age of 8yrs under supervision when using all the facilities.
